

FROM 10 FWY (east-bound)

Exit the freeway at Hoover Street / At the bottom of the off-ramp, turn right on Hoover Street / Take Hoover to where it ends at Jefferson Boulevard / Turn left onto Jefferson Blvd. / Turn right at Grand Avenue / Turn right at 35th Street / Pay the \$10/per car fee at the parking kiosk and park in the Parking Center / Catch the tram at the ground floor, ride to Leavy Library drop-off and follow the signs to the USC Town & Gown Ballroom (approx. 5 minute walk after the tram ride)

FROM 10 FWY (west-bound)

Exit the freeway at Hoover Street / At the bottom of the off-ramp, turn right at the signal and proceed to Hoover Street / Turn right onto Hoover / Take Hoover to where it ends at Jefferson Boulevard / Turn left onto Jefferson / Turn right at Grand Avenue / Turn right at 35th Street / Pay the \$10/per car fee at the parking kiosk and park in the Parking Center / Catch the tram at the ground floor, ride to Leavy Library drop-off and follow the signs to the USC Town & Gown Ballroom (approx. 5 minute walk after the tram ride)
