





First Year: The Foundation

In your first year, you will take eight required courses which are the foundation of all legal scholarship. Classes are small, ranging in size from 15 to 70 students. This intimate classroom experience encourages dialogue and debate influenced by the diverse experiences of USC Gould’s student body and faculty. Our first-year professors bring legal theory to life with creative and interactive lectures and demonstrations.

Electives

In recognition of our 1L students’ diverse interests, backgrounds, and priorities in pursuit of their legal education, USC Gould allows you to choose from among the following core courses:

Business Literacy: Teaches the basics of business and financial concepts that are important to transactional legal work.

Ethical Issues for Public Interest, Government and Criminal Lawyers (Legal Profession): Designed for students who aspire to careers in public interest and the public sector. The class explores the role of the lawyer in society, history, and the organization of the legal profession, alternate career patterns, conflicting duties, the adversary system, equal access to justice, and other issues of ethics and professional responsibility.

Constitutional Law: Rights: Examines many of the key rights protected by the U.S. Constitution with a particular emphasis on equal protection of rights and rights under the due process clause.









Second and Third Years: The Practice

Having acquired a solid foundation in the basic principles of law, the second and third years allow you to pursue the areas of legal and intellectual inquiry that excite you. You will be able to choose from over 200 classes. These can be as small as 10 students, allowing for vigorous debate and one-on-one collaboration with professors.

Many classes include a simulation component that will challenge you to apply legal principles to actual cases.

You may receive credit for serving as an editor or staff member of one of USC Gould's three scholarly journals, participating in Moot Court, working in one of USC Gould's six legal clinics or for a public interest organization, serving in a judicial externship, or engaging in directed research projects.

Certificate Programs

Complement your degree and build additional skills in dynamic specializations by pursuing one of five certificates offered by USC Gould. Our certificates are designed to deepen your knowledge and exposure to a specific area of the law. Each certificate allows you to take advantage of the rich legal landscape of the greater Los Angeles region.

ALTERNATIVE DISPUTE RESOLUTION

Covering one of the fastest-growing areas of law, the Alternative Dispute Resolution Certificate offers two tracks — mediation and arbitration. Each teaches methods for resolving disagreements among parties instead of pursuing costly, time-consuming lawsuits.

BUSINESS LAW

Businesses large and small require informed, resourceful legal professionals to help them thrive. Full-time faculty and practitioners with decades of wide-ranging experience provide you with the skills needed to apply legal concepts and strategic thinking to real-world business problems.

ENTREPRENEURSHIP & TECHNOLOGY LAW

The Entrepreneurship and Technology Law Certificate is designed to provide you with a powerful edge to pursue a career as a transactional lawyer in startup, venture capital, and technology markets. A major theme is the convergence of technology and content. The courses focus on transactional skills through simulated negotiation, drafting, and other active learning exercises. You will participate in individual and collaborative projects and hands-on courses that mimic the experience of a junior associate.

The Media & Entertainment Law Certificate will increase your fluency in law specific to the film, television, and media industries. The courses take a practice-oriented approach that gives you the problem-solving skills and business knowledge to navigate transactional and litigation practices — from intellectual property and patents to copyright infringement and First Amendment issues.

PUBLIC INTEREST LAW

The Public Interest Law Certificate prepares you with the substantive knowledge and practical skills needed for a successful career in nonprofit or government sectors. The certificate builds upon the school's longstanding leadership in public interest law. Courses encompass criminal justice, immigration, civil liberties, mental health, international human rights, and more.

POST-CONVICTION JUSTICE PROJECT (PCJP)

As USC Gould's first clinical program, the PCJP has given over 600 law students the opportunity to fight for second chances on behalf of women and youth offenders serving life terms in California. The clinic has successfully advocated for legislative reform of the parole system and post-conviction sentencing relief.

INTELLECTUAL PROPERTY & TECHNOLOGY CLINIC

You will work on cutting-edge issues in intellectual property, entertainment, gaming, and technology law. Cases involve copyright, trademark, privacy, the fair use doctrine, and First Amendment issues. Clients range from documentary filmmakers to software game developers, high-tech startups, and entrepreneurs.

SMALL BUSINESS CLINIC

You will gain real-world legal experience by helping business owners and fellow USC students working in entrepreneurial ventures who could otherwise not afford legal representation. Issues range from contracts and general business agreements to licensing issues, articles of incorporation, and unforeseen legal problems.

THE INTERNATIONAL HUMAN RIGHTS CLINIC

Students confront the most pressing human rights concerns of our day. You will seek justice on behalf of victims of human rights abuses, argue to hold perpetrators of serious human rights abuses accountable, and advocate for progressive development of the law. Many students and recent graduates have clerked for international tribunal judges at the Hague, as well as in Cambodia, Rwanda, and other parts of the world.



“One of the clinic’s biggest successes in the last five years has been developing partnerships with international criminal tribunals, allowing students to seek justice for atrocity crimes around the world, such as crimes against humanity and genocide. IMMIGRATION CLINIC

Since launching 14 years ago, the Immigration Clinic has represented 185 individuals seeking asylum, relief under the Violence Against Women Act, and other applications for relief from removal. Many cite the fear of persecution and desire for religious freedom in their claims for relief from deportation. These claims are presented by USC Gould clinical students at regional U.S. Citizenship and Immigration Services detention centers around Central and Southern California.

MEDIATION CLINIC

You will learn valuable mediation skills in one of the fastest-growing practices of law. USC Gould offers one of the only Advanced Mediation programs in the country, serving 750 to 1,000 disputants yearly. Participation in the clinic teaches the dispute resolution skills required to become a professional mediator. By the end of the semester, you will have mediated six or more cases in Los Angeles County Superior Court. This is a prime example of putting theory into practice.



“I participated in the mediation clinic; it was absolutely amazing. Being in the clinic gave me the opportunity to be in the courtroom once or twice a week as a mediator. It helped me build my confidence to go into court, speak with the courtroom personnel, interact with the judge, and help people with opposing views come to an agreement. Externships

Externships provide you with the opportunity to work for a legal employer under the supervision of a licensed attorney, engage with real clients, gain hands-on practical experience, and earn academic credit.

Sitting on the Pacific Rim, and in proximity to numerous international, national, and California-based law firms, USC Gould affords you the opportunity to gain practical work experience in general counsel offices, law firms, corporations, and government agencies, as well as technology and media companies.

Taking advantage of our unique location in the world’s entertainment capital, students have externed at major studios, including Fox, MGM, Warner Bros., and Sony Pictures, as well as with record labels such as Universal Music and television networks such as NBC and MTV.

Judicial Externships

Located in Los Angeles, home to the U.S. District Court for the Central District of California and numerous other federal, state, and local courts, USC Gould provides you with the opportunity to earn academic credit while working as an extern for a state or federal judge. Judicial externs develop legal analysis and writing skills, gain exposure to adversarial practice, and witness the judicial decision-making process from a unique and valuable perspective.

USC in DC Program

The “SC in DC Program” offers you a unique opportunity to gain a first-hand account of how federal statutes, regulations, and policies are made, changed, and understood in the nation’s capital. You will have the opportunity to network with all three branches of the federal government, independent regulatory agencies, and advocacy nonprofits beginning the summer after your 1L year.

DURING THE 2014-2015 ACADEMIC YEAR, USC GOULD STUDENTS SECURED 76 JUDICIAL EXTERNSHIP PLACEMENTS. THESE INCLUDED STATE SUPREME COURTS AND FEDERAL COURTS OF APPEAL EXTERNSHIPS.

Honors Programs

Our honors writing programs afford students an opportunity to hone their writing skills — a key component of any legal practice. USC Gould publishes three student-run journals — *Southern California Law Review*, *Southern California Review of Law and Social Justice*, and the *Southern California Interdisciplinary Law Journal*. Our Hale Moot Court Honors Program provides an intensive experience in the development of trial advocacy skills.

Law Reviews and Journals

Southern California Law Review

The *Southern California Law Review* is a journal of legal scholarship managed and edited by students and published six times each year. Founded in 1927, the *Review’s* circulation is among the largest in the nation. The *Law Review* members conduct independent legal research, prepare notes and comments for publication, and edit the works of their peers, along with articles and book reviews submitted by faculty members and other scholars.

Southern California Review of Law and Social Justice (RLSJ)

The goal of *RLSJ* is to influence the development of the law in ways that encourage full and equal participation of all people in politics and society. *RLSJ* publishes three issues a year that consist of professional and academic articles and student notes. It promotes the discussion and examination of issues lying at the intersection of social justice and the law.

Southern California Interdisciplinary Law Journal (ILJ)

The *Southern California Interdisciplinary Law Journal* publishes scholarly articles analyzing the law through other fields of study. *ILJ* publishes the work of law professors, economists, medical doctors, anthropologists, and others who apply the latest findings in their field to legal issues.

Hale Moot Court

During the Hale Moot Court Competition, second-year students write an appellate brief, attend an oral advocacy clinic, participate in videotaped practice rounds, and present their arguments before panels of judges from state and federal courts, practicing attorneys, and faculty members. In the spring semester, the competition culminates with four students competing in a final round of argument before a panel of distinguished state and federal judges.

“Lawyers are problem solvers, especially litigators. The first year of law school teaches you how to think like a lawyer; the first year of moot court teaches you how to advocate for someone, which is the reason I chose to attend law school. I wanted every opportunity I could get to practically apply the skills I was learning. Even if you don’t want to be a litigator, it is so important to be able to withstand questioning, to be able to consider and concede on counter arguments where appropriate, and to think as an advocate. These are all skills you gain as a participant in moot court.”

Later, that clinic became the Legal Aid Foundation of Los Angeles, one of the state's leading providers of free legal services. Today, USC Gould students continue to contribute to the work of the Legal Aid Foundation.

Public Service Programs and Opportunities

USC Gould connects you to countless volunteer opportunities, internships, in-house legal clinics, and grant programs through our Office of Public Service (OPS).

Public Interest Law Foundation (PILF)


PILF is a student-run, nonprofit organization that promotes social justice lawyering, equal access to the law, and the empowerment of marginalized and underrepresented communities. It does so in three main ways:

- 1) PILF organizes pro bono clinic opportunities for students to volunteer with local organizations
- 2) PILF hosts lectures and events at the law school about public interest law issues
- 3) PILF funds students pursuing public interest work over the summer through the PILF grant program

USC Public Interest Volunteer Opportunities

Opportunities include:

- Legal Aid Alternative Breaks (LABB): sponsored spring break trips to the hurricane-ravaged Gulf Coast where students provided crucial legal services to residents rebuilding their lives
- Latino Law Students Association's Teen Court: a diversion program for first-time juvenile offenders in lieu of formal juvenile court proceedings
- Street Law: a nationally recognized educational outreach program that teaches legal literacy to local high school students



Funding for Public Service Work

USC Gould helps students secure the financing that allows them to fund their pro bono and public service efforts through fellowships, stipends, awards, and loan repayment assistance.

Public Interest Scholars

Special merit awards are offered to admitted students dedicated to a career in public service. Beyond scholarship funding, public interest scholars receive guaranteed public interest summer employment and a grant to support that employment. Priority consideration is given to applicants with a history of full-time nonprofit or public interest-focused work.

Graduate Volunteer Grant (GVG)

Our Graduate Volunteer Grant (GVC) Program is a 12-month program that provides recent USC Gould graduates the opportunity to volunteer as lawyers in a nonprofit or public service organization. Graduates work 35 hours a week and are paid through the grant for their time. GVG has supported almost 200 attorneys at a variety of host organizations, including UNESCO, Public Defender's Offices, the Texas Criminal Justice Coalition, and the New York City Law Department.

Fellowships

USC Gould's support for our students continues throughout their professional life. If you are interested in working in public service, we offer an array of fellowships to financially support your goal.

Financial Aid

At USC Gould, we understand that law school is an expensive endeavor, but encourage all students to see it as an investment that is going to pay dividends far into your future. To help offset the cost, we offer a significant amount of scholarship assistance to incoming students.

The Process

Scholarship awards are based upon the strength of the application, and all factors that are considered for admissions are also considered for scholarship decisions. Undergraduate GPA and LSAT score are two of these factors given significant weight, but other strengths of the candidate file are also taken into account. All admitted students are automatically considered for a scholarship award. There is no separate application process other than for those applying under special scholarship programs.

Additionally, our scholarships are guaranteed for three years assuming you remain enrolled full-time and in good academic standing. Scholarship funds are not available to transfer students, nor do we make new awards or increase awards for students rising into their second and third years.

Any difference between the scholarship award and estimated cost of attendance may be covered via student loans. Those interested in federal student aid must remember to complete the Free Application for Federal Student Aid (FAFSA) in a timely manner. This is normally soon after January 1 of each year. The USC school code is 001328.



Special Scholarship Programs

The following programs require a supplemental scholarship application which will be submitted as part of your application.

FRANK ROTHMAN SCHOLARS PROGRAM

This program honors the late Frank Rothman '51, one of the nation's most influential trial lawyers and a legendary sports and entertainment attorney. One Frank Rothman Scholar is selected each year, and the benefits are extraordinary:

- Full-tuition scholarship guaranteed for three years
- \$2,000 stipend each year for three years
- Paid 1L summer fellowship at one of the top law firms in the world — Skadden, Arps, Slate, Meagher & Flom in Los Angeles

Other Forms of Assistance

LOAN REPAYMENT ASSISTANCE PROGRAM (LRAP)

The LRAP provides assistance in repaying loans to graduates who accept employment with public interest organizations. Graduates who work for a qualifying organization will only pay a specified percentage of their earnings towards their loan repayment obligations. The remaining portion will be covered by LRAP funds. All LRAP assistance will be forgiven if you remain in qualifying employment for five years.

Full-Time Faculty

Our 51 full-time faculty members are internationally recognized for their expertise and scholarship in fields as diverse as administrative law, intellectual property, business, entertainment, ethics, and tort reform. Many full-time faculty members have degrees and expertise in both law and a secondary discipline, such as economics, communications, public policy, medicine, history, psychology, and philosophy. Their diverse academic and professional backgrounds contribute to classrooms full of wide-ranging ideas.

Our full-time professors are also accomplished outside of the classroom — six of them have clerked for United States Supreme Court Justices, one of them has served as the national campaign manager for a presidential candidate, another received a MacArthur “Genius Grant” and gave a Ted Talk that’s been viewed nearly 3 million times, and one acted as the Chief of Staff of the U.S. Congress’ Joint Committee on Taxation.

Adjunct Professors Who Practice Law

Given its proximity to Los Angeles’ entertainment, media, and technology companies, major law firms, and public interest agencies, USC Gould has over 100 adjunct professors that bring their real-world practice into the classroom. Learning the law from professors who are current practitioners allows USC Gould students to grasp the nuanced application of theory to problem solving.



Peer Mentors

On the first day of orientation, your class section will be assigned two second-year peer mentors who are available to you throughout your 1L year. Your peer mentors will serve as your sounding boards and cheerleaders.

Peer Tutors

Peer tutors are an integral part of the first-year academic support program. They are three upper-division students who performed especially well in their first year and who have prior experience teaching or mentoring students. One peer tutor is assigned to each large section. The tutors host workshops and send weekly tips throughout the first year. They are also available for individual or small-group tutoring.

Writing Fellows

To supplement tutoring resources, the Legal Writing Fellows Program can help students transition from academic writing to legal writing. Professor Elizabeth Carroll, Associate Vice Dean for Curriculum, Professor of Lawyering Skills, and Director of Legal Writing and Advocacy, encourages first-year students to ask Fellows for assistance because legal writing requires time and effort.

First Generation Professionals Program (FGP)

The needs of our diverse student population have given rise to USC Gould's First Generation Professionals Program. We are committed to creating a path to success for students who are the first in their families to attend college and professional school, or who come from low-income backgrounds. Workshops, seminars, and group sessions provide practical guidance and a safe space where you can share experiences, ask questions, and forge a sense of community. Alumni mentors with similar backgrounds are active participants, creating an early and on-going connection with the professional community.

Finding the Right Job

From the beginning of your legal studies, the Career Services Office works with you to tailor an individualized plan in preparation for your transition to the practice of law. In October of your 1L year, a career service counselor will sit down with you and begin a conversation focused on your individual career path and help you build an action plan. They will work with you to build a résumé, refine your interviewing skills, and define what type of law and in what environment you may want to practice. Then together, you will begin the process of building a target employer list.

At the Spring Alumni 1L Mentor Lunch, Career Services makes sure that every student is assigned to a table with alumni in the area of law in which they are interested so they can begin to network.

On-Campus Interviews (OCI)

In August, prior to second year, USC Gould orchestrates a number of on-campus events where students interview with local, national, and international law firms, corporations, and federal government agencies. In preparation, starting in early July, Career Services staff reach out to students to help them refine their résumés and prepare for the OCI process.

Job Fairs Outside of Los Angeles

While many USC Gould graduates pursue rewarding careers in the Southern California legal community, we also recognize that others wish to establish their careers in Northern California and in various markets across the country. The Career Services Office actively supports students' desires to conduct both regionally based and nationally based job searches. We hold market-specific career programs on campus each spring and host annual job fairs in San Francisco, the Silicon Valley, New York City, Washington, D.C., and Chicago.

Judicial Clerkships

Judicial clerkships are a key credential for your future practice of law no matter what area of legal specialty you choose. USC Gould alumni have held judicial clerkships in the United States Supreme Court, the Court of Appeals, district courts, and state courts throughout the country.

Mentoring for Clerkships

If you are interested in pursuing a post-graduate judicial clerkship, beginning in your first year, USC Gould offers mentoring which will enable your plan to become a reality. Throughout the first year, you will be invited to attend receptions and lunches hosted by USC Gould, so you can learn the benefits of clerkships from judges who offer them.

In your second year, you will work with our dedicated judicial clerkship counselor and our Faculty Clerkship Committee. They will advise you on how to target the judges for whom you’d like to clerk, equip you with strategies for applying to those judges, and, as much as possible, work to set up meetings with alumni judges to prepare you for your interviews.
