In addition, the *Journal* endorses a policy of gender neutrality in legal scholarship and may revise an article to use gender-specific language in accordance with this policy. Use of gender-neutral language in articles published by the *Journal* reflects support of this policy and is not necessarily indicative of the authors' policies or opinions. Unfortunately, submissions cannot be returned unless postage is provided.
